Did you know?

Cobb EMC incurs a significant expense every year to print and mail this Election Ballot Packet. The use of email to send it could reduce this cost substantially. The online voting website includes a section where you can authorize Cobb EMC to email future Election Information to you instead of mailing this printed paper packet. Please help reduce our costs by voting via the website and, when prompted, providing your email address and agreeing to receive future election information electronically. Bylaw revisions – as approved at 6/24/25 Board of Directors meeting. Each section will be voted on separately by the members. In the following bylaw amendment proposals: <u>Underlined</u> print indicates words being added to the bylaws.

<u>Strikethrough</u> print indicates words being removed from the bylaws.

Section 2.13 Credential and Election Committee

The Credentials and Elections Committee shall consist of an unevennumber of Members not less than three (3) nor more than fifteen (15) nine (9) Members.

Each Director may nominate at least one (1) member to the Credentials and Elections Committee, who shall serve a term of one (1) three (3) years, concurrent with the respective nominating Director or until the next Cobb EMC Board of Directors election is completed, whichever comes first. All nominations shall be made not later than the second Friday in May in any given year, and subsequently approved by a majority of the Directors present and voting at the time of the vote January regular Board meeting.

The proposed amendment amends the nomination and approval process for the Credentials and Elections Committee. Appointments need to be made earlier in the year to allow for the selection of an independent election services provider and the terms have been adjusted to align with other committees.

The changes to this section have been reviewed by legal counsel and come with the Board's recommendation for approval.

Section 3.04 Qualifications of Directors, (e)

not have been, within five (5) years immediately preceding the date of the Annual Meeting in which the directorship is to be voted upon, an employee of the Cooperative or an affiliate of the Cooperative, an employee or director of a competing utility or enterprise, a Close Relative of an employee of the Cooperative, or a Close Relative of an employee or director of a competing utility or enterprise. Individuals who were employed as Chief Executive Officer ("CEO") or as a direct report to the CEO are not qualified for directorship at any time;

The proposed amendment excludes employees of an affiliate company of Cobb EMC from directorship.

The changes to this section have been reviewed by legal counsel and come with the Board's recommendation for approval.

Section 3.04 Qualifications of Directors, (h) and (i)

- (h) have attended two (2) regular monthly Board meetings and two Budget and Finance
 Committee meetings prior to qualifying for election within twelve (12) months of qualifying;
- if not an Incumbent, attend a candidate information meeting prior to qualifying, and attend a candidate orientation meeting after qualifying.

The proposed amendment adds two qualification requirements. This requires potential candidates to become familiar with the complex operations of the Cobb EMC enterprise by requiring attendance at two board meetings and two Budget and Finance Committee meetings before qualifying and gives potential candidates the opportunity to understand the commitment of becoming a Cobb EMC director.

The changes to this section have been reviewed by legal counsel and come with the Board's recommendation for approval.

Section 3.05 Director Term Limits

Starting with elections in 2014, Directors shall not be eligible to be nominated or elected to serve for more than four (4) five (5) full terms as a Director.

The proposed amendment would change the Director term limit from four terms to five. Under the current bylaws, the entire Board is scheduled to turn over within a 24-month period between September 2026 and September 2028, resulting in a significant loss of industry knowledge and experience in running a successful company. The amendment would allow current Directors to run for one additional three-year term, helping preserve institutional knowledge. It would also enable new Directors to join in a staggered manner if some current Directors are not re-elected or choose not to run.

The changes to this section have been reviewed by legal counsel and come with the Board's recommendation for approval.

Section 3.06 Notice of Expiring Director Terms

The Cooperative shall ensure that a notice is provided by any reasonable means permitted by Section 7.11 of these Bylaws delivered to all Members not later than the second Fridayin April end of October notifying Members of the name of all Directors whose term of office will expire at the next Annual Meeting.

The proposed amendment increases the notice period from April prior to the Annual Meeting to October prior to the Annual Meeting. This allows additional notice to interested candidates so they can become more involved with the cooperative before candidate qualifying ends in May. Thus allowing individuals additional time to decide if they would like to become candidates for the board.

The changes to this section have been reviewed by legal counsel and come with the Board's recommendation for approval.

How many Cobb EMC Annual Meetings have you attended?

I've attended over 15 annual meetings. I realize the privilege of being a member-owner and the importance of participating in the direction of the co-op and electing Board members. Since 2012, I have only missed two meetings.

Community Service/Involvement:

As a Deacon and active member at Mars Hill Presbyterian Church, I serve with integrity and compassion. For the past decade, I've hosted an annual fundraiser on our Burnt Hickory Road property to benefit KCK Children's Home in Kenya which supports over 300 children, four homes, and a technical school. This event is well known to many District 8 members who have attended and supported over the years.

I've also worked with ASTM, helping set standards for the electrical industry, and served on utility industry committees, including labor contract negotiations.

Professional Background/Experience:

With over 40 years in the electric utility/construction industry, I am a Georgia unrestricted licensed electrical contractor. My background includes serving as Director of Safety, where I managed training, OSHA compliance, workers' compensation, corporate liability, and environmental standards, critical components of operational accountability. I understand the day-to-day requirements and sometimes adverse conditions associated in an inherently hazardous industry.

For the past seven years, I've owned and operated E. Benson Construction LLC, gaining hands-on experience in leadership, budgeting, and strategic planning. My education and field experience equip me with a well-rounded view of the business, technical and safety needs that affect Cobb EMC and its members.

How will my skills and expertise benefit the cooperative?

Family & Community –

David McClellan and his wife (Carmen) have lived in Cobb County and have been members of Cobb EMC for 35+ years. Their two children attended East Cobb schools where they graduated from Pope High School, and both received degrees from

Georgia State University. David has been active in the community coaching youth softball for many years and has been involved in the children's programs at several local churches. He was also involved with the Y-Guides parent/child program. In his down time David enjoys music, college football and classic automobiles as he is a member of the Atlanta Austin Healey Club.

Business Credentials – David McClellan has over 40 years of financial and accounting experience in public accounting, with Fortune 500 companies, as well as privately held companies and has served as CFO for companies in Atlanta for over 20 years . He is a Certified Public Accountant, a Certified Cash Manager and holds a Six Sigma certification. He has an undergraduate in Accounting (graduated Summa Cum Laude) and he holds an MBA in Finance from Georgia State University.

Cobb EMC Board Member – He was elected to the board of Cobb EMC in 2012 promising transparency, member control, and a return to financial stability. As with almost everyone on the current board, he ran as a strong proponent of term limits. He stated, "In my opinion term limits are in the best interest of the members:

- With regular turnover, term limits can provide an opportunity for new perspectives and ideas to be brought to the EMC
- Term limits could force directors to be more accountable to the EMC's members
- Term limits can help counteract the advantages that incumbents often have in elections, such as name recognition and resources
- Over 10 years ago, many directors argued that term limits can help reduce corruption by preventing directors from building up too much power and influence over time"

Cobb EMC is a not-for-profit cooperative. As a member of this electric cooperative, you benefit from our focus on serving you, and through the cooperative you have the opportunity to make a difference in our community.

Low Rates

- Ranked the most affordable electric utility in Georgia with the lowest rates in Georgia three years in a row.
- Since January 2013, Cobb EMC has given back \$75.7 million in power cost adjustments to members.

- Since 2021, Cobb EMC has given back \$43.9 million in capital credits to members.
- Controlling operating expenses is a high priority currently Cobb EMC is 20% lower than peer group for expenses per member.
- In the past 3 years, Cobb EMC has absorbed (not passed on to members) approximately \$16.8 million of incremental power costs.

Improve Electrical Reliability

- In 2024, Cobb EMC ranked first in the nation for providing reliable power, according to the Institute of Electrical and Electronics Engineers' 2024 benchmark year study results.
- Also, Cobb EMC was also ranked first for restoring outages quickly.

Customer Focused

- Cobb EMC's customer service group received an award for best in class in the nation on a Customer Service Phone Satisfaction survey.
- In 2024 Cobb EMC received a J.D. Power score of 785, ranking third according to J.D. Power.
- For the last three years, Cobb EMC has received American Customer Service Index scores of 92, which is 18 points higher than the average investor-owned utility, and 17 points higher than average municipal utility score of 75.

Encourage Renewable Energy where Appropriate

- By 2030, Cobb EMC has committed to having a 200% increase in renewable energy and reducing carbon emissions by 75%. To reach this goal, Cobb EMC will continue to look at the long-term economics and benefits of solar.
- In the past 6 years Cobb EMC has entered into agreements to purchase 175 megawatts (MW) of solar energy from projects constructed in GA.
- The addition of electric vehicles to the company's fleet, the creation of the first Solar Flower Garden, campuswide rooftop solar panels, a battery storage building, and a microgrid project are all steps the cooperative is taking to research and develop renewable energy on its corporate campus.

Community Service

- Through Operation Round Up and the generosity of our members, the Cobb EMC Foundation has given more than \$9.3 million to local non-profits in all five counties that Cobb EMC serves. Additionally, they have provided \$70,000 each year in scholarships to local students.
- This year Cobb EMC awarded more than \$38,000 in Mini-Grants to 81 teachers across our five-county service area. These grants helped fund various experiential and active learning projects for students, including career preparation, STEM programs, community gardens, and expansions in art and music.
- Cobb EMC was recently named EMC of the Year and presented the Georgia EMC Community Service and

Volunteerism Award for unprecedented generosity and service to thousands of residents in the five metro Atlanta counties they serve.

Culture of Safety

- Cobb EMC has finished below the electric cooperative state and national average over the last five years on the injury incident rate.
- In the last Electric Cooperative Safety Accreditation Program (ECSAP) inspection performed by Georgia EMC, Cobb EMC was awarded an 'Exceeding Expectations, Outstanding Performer' rating.
- Cobb EMC provides community electrical safety awareness presentations for members, general public, schools, first responders, and other utilities.



TRIPPER SHARP (Incumbent) District 5 - Uncontested

Tripper Sharp has served on the Cobb EMC Board of Directors since 2012. During his tenure, he has held numerous leadership roles, including four years as Board Chairman, two years as Vice Chairman, and several committee chairmanships. He also serves on the

management committee of Gas South and as a board member of the Georgia Electric Membership Corporation.

With over 25 years of leadership experience in executive roles across the financial services and healthcare industries, Sharp currently serves as President and CEO of Sharp Home Care. He leads a team of Registered Nurses, Certified Nurse Aides, and credentialed caregivers who assist seniors with daily activities, enabling them to live safely and independently at home. Sharp Home Care supports individuals who are aging, managing chronic health conditions, recovering from medical setbacks, or living with special needs or disabilities.

Sharp was a founding member of the Cobb EMC Owners Association and has served on numerous state and local boards. He holds a bachelor's degree from Kennesaw State University and has earned the Credentialed Cooperative Director (CCD), Board Leadership Certificate (BLC), and Director Gold (DG) certification from the National Rural Electric Cooperative Association. He resides in the Autumn Ridge subdivision with his wife, Marlo, and their four active children.

I was elected to the Cobb EMC Board on the promise that the cooperative would uphold the principles on which it was founded in 1938. I committed to promoting transparency and operating with sound business and ethical standards. I believe this Board—and the many dedicated Cobb EMC employees—have fulfilled those promises.

After the election, it became evident that Cobb EMC was burdened by institutional inefficiencies that increased the cost of service. The company had a poor safety record, relied heavily on overpriced consultants and contractors, and was entangled in a costly lawsuit with its members over the return of patronage capital—spending millions fighting those it was meant to serve.

Recognizing the responsibility entrusted to us in 2012, the Board took decisive, principled action to address past mismanagement. Our mission was clear: restore integrity and strengthen Cobb EMC without exacerbating existing issues.

We focused on operating efficiently while maintaining high reliability standards. In 2024, Cobb EMC was ranked #1 nationally for power reliability by the Institute of Electrical and Electronics Engineers—an outstanding testament to our team's strategic use of technology and resources.

When I was first elected, Cobb EMC members paid some of the highest electricity rates in Georgia, driven by mismanagement and waste. Since then, the Board has prioritized cost-saving initiatives and efficiency improvements, resulting in multiple rate reductions. Even amid today's economic climate, Cobb EMC has avoided many of the costly rate hikes seen across the industry, ensuring that electricity remains affordable for our members.

Our members are now benefiting from the Board's commitment to operational excellence. Cobb EMC is viewed as a model of efficiency by more than 900 cooperatives across the nation and consistently maintains some of the lowest rates among Georgia's electric co-ops. For the past three years, Cobb EMC has had the lowest electric rates in the state—well below those of Georgia Power—thanks to smart planning and disciplined operations.

Additionally, our subsidiary Gas South has returned over \$118 million in dividends in 2024, further reducing costs for members.

As long as I have the privilege of serving on the Cobb EMC Board, I will remain steadfast in upholding cooperative principles, championing transparency, and leading with integrity.
